

PRIVACY POLICY

This policy (together with any other documents referred to) sets out the basis on which we will process personal data we collect from you, or that you provide to us, as a result of your use of our web site or services. It supplements and should be read in addition to other terms and conditions that you have agreed to in connection with your use of our web site or our services. INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

- Information that you provide to us.
- Information provided by others about you.
- Details of your visits to our site and the resources that you access.

WHERE WE STORE YOUR PERSONAL DATA

For domain registration data only:

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff maybe engaged in, among other things, the processing or fulfilment of applications, and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data

For all other business:

We do not store your information anywhere other than our own servers on the Isle of Man and we take all necessary precautions to keep that data safe and secure.

We use information held about you in the following ways:

- To provide you with information, products or services that you request from us or which we feel may interest you, where you have consented to be contacted for such purposes.
- To carry out our obligations arising from any contracts entered into between you and us.
- To allow you to participate in our applications process.
